

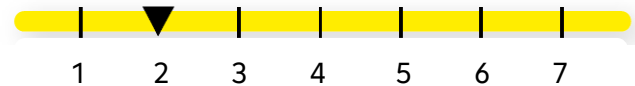
RAIFFEISEN EURO PREMIUM SHORT BOND FUND

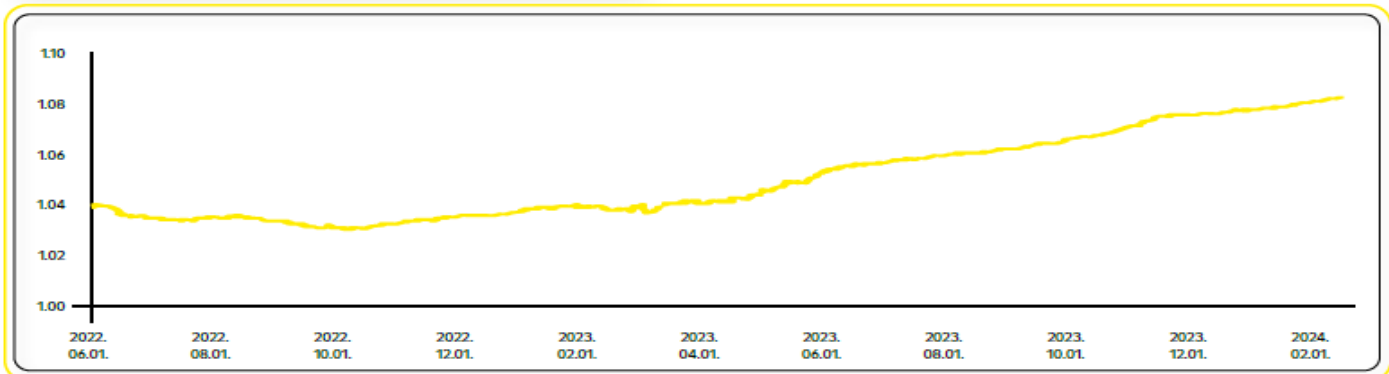


KIID risk level (SRRI)

SHARE CLASS 'A' (EUR)



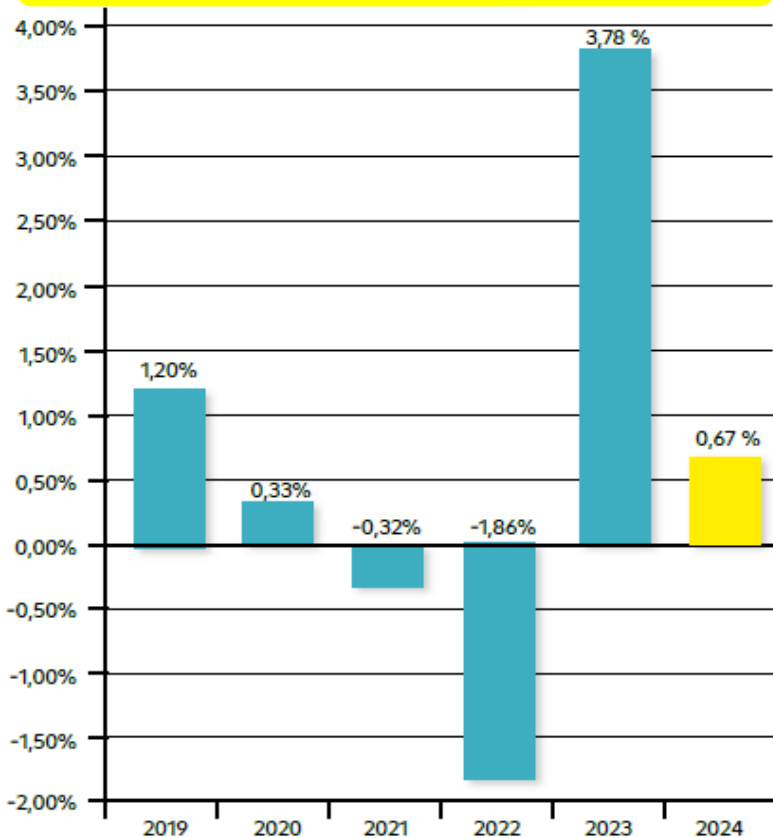
